**Human Health Hazards** : *Respiration* : May cause irritation, dizziness, nausea and loss of consciousness.

### 4 FIRST AID MEASURES

## 5 FIRE-FIGHTING MEASURES

- Extinguishing Media** : Use foam, CO2, dry powders and water mist. Do NOT use a high pressure water jet.
- Recommendations** : Decomposed products are a health hazard. Use appropriate breathing apparatus. Cool closed containers exposed to fire with Foam not water Jets to prevent ignition.

## 6 ACCIDENTAL RELEASE MEASURES

- Personal Precautions** : Ventilate the area. Avoid breathing in vapours. Remove all sources of ignition e.g. flames, sparks, static electricity and heat.
- Spill** : Contain and collect spillage with absorbent material. Dispose of according to local regulations. Do not allow spillage to enter sewerage drains or watercourses.

## 7 HANDLING AND STORAGE

- Handling** : Keep container tightly closed. Keep away from heat, sparks and flame. Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. After handling the material, workers should wash hands and face before eating, drinking and smoking. Always comply with health and safety regulations.
- Storage** : Store in original container. Observe label precautions. Store in a cool, well-ventilated area away from incompatible materials and ignition sources. Keep away from oxidizing agents, strong alkaline and acids. No smoking. Containers which have been opened must be carefully resealed and kept upright to prevent leakage.

## 8 EXPOSURE CONTROL/PERSONAL PROTECTION

- Engineering Measures** : Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of particulates and solvent vapour below the OEL, suitable respiratory protection must be worn.
- Personal Protective Equipment** :
  - Respiration** : Should ventilation be inadequate or if workers are exposed to concentrations above the exposure limit, appropriate certified respirators must be used.
  - Eyes** : Use safety eyewear designed to protect against splash of liquids. Never touch eyes with dirty hands or gloves.
  - Ingestion** : Observe the rules of hygiene. Wash hands and face before eating, drinking or smoking.
  - Skin** : Use protective gloves. Wash immediately in case of contact.
